Time limit

One 2 minute round
1 minute overtime
Double elimination tournament format

Rules

No elbows
No knees to the head, knees to the body are allowed.
Strikes to the back or groin are illegal and are subject to disqualification.
Direct strikes to the knees are illegal.

Ways to win

Judges decision
Opponent gives up
Opponent is disqualified

Criteria

Match will be judged by 3 experienced judges
Judged on superior technique, control, placement of strikes.
Over aggression will lead to disqualification
